presents. The receipt hereof is hereby acknowledged hath granted bargained  
sold, released and confirmed and by these presents hath granted aforesaid  
all the aforesaid and confirm unto the said George McLeod his heirs and  
Assignees forever a certain tract piece or parcel of land situate on the  
Beach Settlement of Kingsdale Gulf Shore District County and province  
aforesaid and is bounded on the east by the present road leading  
to Antigonish opposite to land owned owned in his life time by one Duncan  
McGillivray & Allan McPherson on the south by lands in possession of John  
McDonald alias by John on the west by the line which divides the present

until it comes to lands in possession of others there about eleven rods  
west eighty four rods beginning on south by one column on the west by lands  
in possession of others on the north by lands in possession of Alexander M Isaac  
in the east by lands granted to Doctor Thomas Hoggan containing two  
hundred acres more or less to a lot of land situate lying and being in  
Morristown so called in the County of Antigonish bounded on the south by  
lands of Neil Kennedy and running along shore a chain North five  
degrees east two chains there North forty eight degrees west one hundred and  
twenty seven chains there South twenty degrees east until it meets the  
Bay Shore or place of beginning containing twenty five acres more or  
less together with all and singular the houses outbuildings barns stables  
and other buildings
