whereas under and by virtue of Section 75 of the Lands and Forests Act 1935, and of every other power and authority in him vested in that behalf, the Governor-in-Council on the recommendation of the said Attorney General acting as aforesaid did by an Order made on the Twenty-seventh day of January in the year of Our Lord One Thousand Nine Hundred and Forty-seven, authorize the purchasing and reconveying to His Majesty for the benefit of the Province of the land hereinafter described;

AND WHEREAS the Grantor hath agreed to sell and reconvey the said land to HIS MAJESTY for the benefit of the Province for the consideration hereinafter mentioned:

NOW THIS INDENTURE WITNESSETH that the Grantor for and in consideration of the sum of Fifty Dollars (\$50.00) of lawful money of Canada to the Grantor in hand well and truly paid by the Grantee at or before the sealing and delivery of These Presents, the receipt whereof is hereby acknowledged, hath granted, bargained, sold, aliened, enfeoffed, released, remised, conveyed and confirmed, and by These Presents doth grant, bargain, sell, alien, enfeoff, release, remise, convey and confirm unto the Grantee, his heirs, successors and assigns, all the following lot of land and premises situate in the County of Antigonish in the Province of Nova Scotia, and more particularly described as follows:

ALL that certain lot, piece or parcel of land situate, Maying and being at Hartshorne Grant in the County of Antigonish, N 340 and being the Eastern one-half part or moiety of lot number 3 in Range 11 of the Hartshorne Grant as marked and designated on a plan of subdivision of said Grant on file in the Registry of Deeds at Antigonish.

And the buildings, hereditaments, easements and appurtenances to the same belonging or in any wise appertaining, and the reversions, remainders, rents, issues and profits thereof, and all the estate, right, title, interest, claim, property and demand of the Grantor of, in, to or out of the same;

TO HAVE AND TO HOLD the same unto and to the use of the Grantee, his heirs, successors and assigns forever.

And the said ANNA RHODA HINGLEY MacGILLIVRAY for herself, her heirs, executors and administrators doth hereby covenant with the Grantee, his heirs, successors and assigns, that the Grantor hath a good, sure, perfect and indefeasible estate of inheritance in fee simple in the said land and premises, and good right, full power and absolute authority to grant and convey the same in the manner and form aforesaid according to the true intent and meaning hereof, and that the same are free from encumbrances, and that the Grantee, his heirs, successors and assigns shall and may at all times hereafter peaceably and quietly hold and enjoy the said land and premises with the appurtenances without hindrance or disturbance of, from or by the Grantor, or any person or persons whomsoever lawfully claiming the same or any part thereof, and that the said ANNA RHODA HINGLEY MacGILLIVRAY, her heirs, executors and administrators, the said land and premises unto the Grantee, his heirs, successors and assigns, against the lawful claims and demands of all persons whomsoever shall and will by These Presents warrant and forever defend.
